## RURAL MUNICIPALITY OF PRAIRIE LAKES

### BYLAW NO. 10, 2015

#### BEING A BY-LAW OF THE RURAL MUNICIPALITY OF PRAIRIE LAKES FOR ESTABLISHING AND MAINTAINING A SYSTEM FOR THE COLLECTION, REMOVAL AND APPROPRIATE DISPOSAL OF SOLID WASTES AND RECYCLABLE MATERIALS WITHIN THE R. M. OF PRAIRIE LAKES.

WHEREAS Section 232 (1) of The Municipal Act, C. M225, in part provides:

"A council may pass by-laws for municipal purposes respecting the following matters:

(a) the safety, health, protection and well-being of people, and the safety and protection of property;"

AND WHEREAS the Rural Municipality of Prairie Lakes wishes to pass a bylaw to establish a disposal policy for all household and non-household waste at all landfill sites within the municipality.

AND WHEREAS the Council of the Rural Municipality of Prairie Lakes deems it expedient to regulate the operation of the municipal garbage disposal sites.

NOW THEREFORE the Council of the Rural Municipality of Prairie Lakes, in Council duly assembled, enacts as follows:

## 1.DEFINITIONS

- 1. *Household waste* means all waste generated within the household and does not include bulky items such as furnishings, carpets, mattresses, stoves, and washers. Household waste does not include any materials used in the construction, demolition and/or renovation of buildings and does not include recyclable material and non-collectable wastes
- 2. *Bulky items* means items such as furnishings, carpets, mattresses, refrigeration units, stoves, washers, etc.
- 3. *Untreated wood*, means wood that is not painted, pressure-treated, soaked with creosote or any other toxic substance
- 4. *Clean construction, demolition and renovation materials* means, but is not necessarily limited to the following:
  - 1. manufactured waste
  - 2. broken plaster, lumber, lumber, rubble, shingles or other waste or residue resulting from the construction, alternation, repair, demolition or removal of any building or structure
  - 3. stock of any wholesaler which shall be regarded as manufactured waste
  - 4. wire, wire mesh and fencing
  - 5. discarded plumbing sinks, toilet bowls and seals, pipe fittings and hot water tanks
    6. loose minor rubble
- 5. *Brush* means trees, branches, stumps and roots
- 6. *Household hazardous waste* means waste generated from a dwelling and designated by the Rural Municipality of Prairie Lakes as acceptable at a household hazardous waste depot and includes the following:
  - 1. corrosive wastes such as car batteries, drain cleaners and oven cleaners that wear away many materials and can cause burns to your eyes and skin
  - 2. flammable wastes such as paints, solvents, oils, varnishes, stains, gasoline, kerosene and B.B.Q. starters and lighter fluid that may ignite if exposed to a spark or flame
  - 3. explosive wastes such as pressurized aerosol cans that can explode if exposed to heat, pressure of puncture
  - 4. poisonous or toxic wastes such as pesticides, rat poison, pharmaceuticals, medicine, pool chemicals, ammonia, bleach and cleaning fluids that may be poisonous or lethal to humans or pets if swallowed or inhaled

- 7. *Compost-able material* means any compost-able material and includes grass cuttings, garden refuse, leaves and organic kitchen waste
- 8. *Recyclable material* means all material designated by the Rural Municipality of Prairie Lakes as per Schedule B
- 9. *Scrap metal* means material with metal content including appliances, aluminum siding, bedsprings, and metal beds and/or articles acceptable to the scrap metal program
- 10. *Boats* means wooden, fiberglass, form of plastic less than 20 feet in length with all engines, components, oil reserves and fuel tank removed.

# 2. Rules and Regulations Governing Disposal of Waste within the Rural Municipality of Prairie Lakes

- 1. A person or ratepayer of the Municipality, residing outside a Local Improvement District, shall deposit waste at the Belmont Waste Disposal Site NW 17-5-15WPM/ Dunrea Waste Disposal Site .
- 2. No person shall deposit or otherwise dispose of any waste brought in from outside the Rural Municipality of Prairie Lakes, upon any lands, whether publicly or privately owned including any waste disposal site established by the Rural Municipality of Prairie Lakes.
- 3. All household waste, compost-able material and recyclables must be deposited at the designated landfill site within the Rural Municipality of Prairie Lakes.
- 4. Items containing the gas Freon must provide a certificate/tag to the Waste Disposal Site Supervisor stating the Freon gas has been safely removed. If no certificate/tag is in evidence disposition of the item will be subject to the applicable fees set out in Schedule C.
- 5. No person shall scavenge, interfere with, remove, exchange or scatter any waste found at the landfill site.
- 6. No person shall deposit or otherwise dispose of the following items anywhere within the landfill site within the Rural Municipality of Prairie Lakes:
  - 1. household hazardous waste listed in Section 1.6, unless otherwise authorized by the Rural Municipality of Prairie Lakes
  - 2. used vehicles
  - 3. pathological diseased materials including syringes, bandages, poultices, dressings and any other medical waste of refuse from any medical clinic, dental clinic, veterinarian clinic, hospital or mortuary
  - 4. explosives or highly combustible materials
  - 5. liquid waste of any kind
  - 6. hay, straw and manure
  - 7. carcass of any animal
  - 8. live animals or birds;
  - 9. ashes that are live or warm
- 7. No person shall deposit any waste at or near, or outside or around at the landfill sites except in the appropriate areas for waste and/or recycling receptacles.
- 8. In any proceedings pursuant to this bylaw, evidence of any personal markings, writings, or inscriptions found in any waste deposited in contravention of this bylaw that identify the name and address of any person shall be prima facie evidence that the waste was deposited unlawfully by such person
- 9. Subsection 2.8 does not apply to industrial or commercial markings
- 10. No contractor shall deposit waste at the landfill site without the express authority of Council and without payment of fees, if applicable, as per Schedule C and determined from time to time by resolution of Council.

## **3.ADDITIONAL REGULATIONS**

- 1. Everyone using the landfill sites must first see the Waste Site Supervisor when entering the site. The attendant has the right to inspect all material entering the landfill site and may not accept materials that are contaminated with items not accepted at the landfill sites. All materials being deposited at the landfill site must be disposed of at areas designated by the Supervisor
- 2. The hours of operation of the landfill sites as per Schedule A will be established by resolution of Council from time to time.

### 4.PENALTY AND LIABILITY FOR EXPENSES

Every person who contravenes or fails to comply with any of the provisions of this Bylaw is guilty of an offence and upon conviction is liable to a fine not exceeding the maximum provided under The Summary Convictions Act C.C.S.M. c. S230 exclusive of costs.

Any costs and expenses for services provided by or on behalf of the Rural Municipality of Prairie Lakes, or for which the Rural Municipality of Prairie Lakes is liable in endeavoring to remove waste, garbage or other refuse caused by or resulting from a person contravening or failing to comply with any provision of the Bylaw shall be fined pursuant to Section 249 of *The Municipal Act*, and shall constitute a debt of such person to the Rural Municipality of Prairie Lakes.

Any fine imposed pursuant to this Bylaw as per Schedule D shall be payable within thirty (30) days after the Rural Municipality of Prairie Lakes has delivered or sent by prepaid registered post an invoice to the person in contravention of the bylaw, commencing on the 31st day following the delivery or sending of the invoice.
